**ORDINANCE NO. 2023-006**

**AN ORDINANCE ESTABLISHING A HOSPITAL BLOOD BANK WITH ADDITIONAL  
FUNCTIONS (HBB++) WITH INCLUSION OF ADDITIONAL SECTIONS (SEROLOGY/IMMUNOLOGY,  
MICROBIOLOGY AND ANATOMIC PATHOLOGY AT THE CAINTA MUNICIPAL HOSPITAL**

**WHEREAS**, Republic Act 7719 otherwise known as the National Blood Services Act of 1994 provides that the following are policies of the State:

- To promote and encourage voluntary blood donation by the citizenry;
- To provide for adequate, safe, affordable and equitable distribution of blood and blood products;
- To mandate the Department of Health to establish and organize a National Blood Transfusion Network in order to rationalize and improve the promotion of adequate and safe supply of blood;

**WHEREAS**, the centralization of collection, testing and processing of blood and its components is a global strategy advocated by the World Health Organization in the provision of an adequate supply of safe blood;

**WHEREAS**, the establishment of a Blood Bank Section shall be beneficial to patients seeking treatment at the Cainta Municipal Hospital;

**NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF CAINTA, IN A SESSION DULY ASSEMBLED THAT:**

**Section 1.** A Hospital Blood Bank with additional functions (HBB++) and additional sections such as Serology/Immunology, Microbiology and Anatomic Pathology is hereby established and shall form part of the Cainta Municipal Hospital.

Let copies of this Ordinance be furnished all concerned offices for their information, guidance and implementation.


